BYLAW NO. 214/95

A BYLAW TO PROVIDE FOR ENTERING INTO AN AGREEMENT WITH OTHER MUNICIPALITIES FOR THE PURPOSE OF ESTABLISHING A CORPORATION FOR THE MANAGEMENT OF FORDYCE MANOR, McMORINE MANOR, AND THE COTTAGES FORMERLY OWNED BY THE ASSINIBOIA PIONEER LODGE INCORPORATED.

THE COUNCIL OF THE TOWN OF MOSSBANK IN THE PROVINCE OF SASKATCHEWAN, ENACTS AS FOLLOWS:

1. PURPOSE

THE PURPOSE OF THIS BYLAW IS TO ENABLE THE COUNCIL TO ENTER INTO AN AGREEMENT WITH NEIGHBORING MUNICIPALITIES TO ESTABLISH CORPORATION TO MANAGE THE AFFAIRS OF FORDYCE MANOR, McMORINE MANOR, AND THE COTTAGES ALL FORMERLY UNDER THE NAME OF ASSINIBOIA PIONEER LODGE INCORPORATED.
