

A BYLAW TO ESTABLISH HEAVY VEHICLE ROUTES

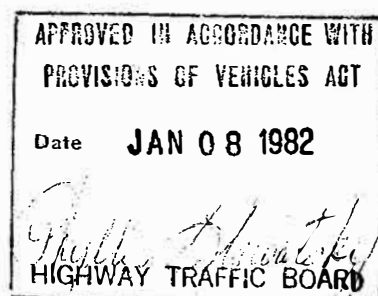
The council of the Town of Mossbank, in the province of Saskatchewan, enacts as follows:

1. For the purpose of this Bylaw "heavy vehicle" shall mean a motor vehicle with or without load which alone or together with any trailer, semi-trailer or other vehicle being towed weighs 15,000 pounds or more.
2. No person shall drive a heavy vehicle on any public highway or portion thereof in the Town of Mossbank except on those public highways or portions thereof that are hereby established as heavy vehicle routes and are set out in Schedule "A" which is attached hereto and forms part of this bylaw.
3. Section 2 of this bylaw shall not apply to:
 - (a) Any person operating a heavy vehicle owned by town actually in the service of the town.
 - (b) Any person operating a heavy vehicle for the collection or delivery of goods or passengers within the town limits. However, a person operating a heavy vehicle proceeding to or from a point of collection or delivery shall proceed to or from such point by or to the nearest heavy vehicle route.
 - (c) Any person operating a heavy vehicle that is proceeding to or from the business premises or residence of the owner or driver of such heavy vehicle.
 - (d) Any person operating a heavy vehicle proceeding to or from a garage, shop or repair depot for the purpose of repairs or servicing.
 - (e) Any portion of a provincial highway that may be within the Town limits.
 - (f) Any person operating an emergency vehicle.
4. Any Police Officer or any person designated by resolution of council may require the driver of any vehicle to weigh same at the nearest scale forthwith within the town limits. A certificate issued by the person or persons in charge of the scale, showing the weight, shall be deemed conclusive on the matter of weight.
5. Any person guilty of an infraction of the provisions of this bylaw shall be liable to the penalties provided in the general penalty bylaw of the town.

This bylaw shall take effect and come into force on the approval of the Highway Traffic Board.

HEAVY VEHICLE ROUTES

<u>NAME OF STREET</u>	<u>BETWEEN</u>
1. Railway Ave. C.N.	Eastern Town Limits to Third Street
2.	Intersection of First Ave. & Third Street to Northern limits of Town.
3. Chaplin Ave.	Third Street to South Western Limits of Town
4.	From intersection Third Ave. South and Chapman to junction to Railway Ave. C. P.
5.	From 3rd Ave to Third Street all of Railway Ave. C.P.
6.	Short Road
7. Brink Street	From Short Road to the North Westerly limits of Town.
